

Knox County, Illinois American Rescue Plan Act (ARPA) Funding Application Form

Knox County is dedicated to the responsible administration of American Rescue Plan funds, investing in resilient public services and supporting community-driven projects to deliver inclusive, innovative, long-term benefits across the County as it recovers and transforms from the pandemic. Applications are open to organizations throughout the County, including community-based organizations, businesses, non-profits, local governments, and similar entities.

Eligibility

To be eligible for ARPA funds, projects must show that:

- the problem they address was caused or significantly exacerbated by the COVID pandemic
- the project will address the problem
- the project will strengthen the County's ability to respond to future pandemics

In addition, application proposals must fall within a single eligible Expenditure Category established by ARPA (see *Appendix I* and fulfill ongoing reporting requirements. Applications will be evaluated across a range of factors, determined by federal reporting requirements and County priorities. These criteria include:

- The issue/problem being addressed
- The impact of the project relative to its cost and effort
- Proposed project budget
- Sustainability of the project
- Project risks and uncertainties
- Availability of other funding sources (e.g., matching grants and collaboration)
- Plan for performance tracking and reporting
- Timeline: Project must be complete and all funds expended by December 31, 2026.

Successful applications should detail a well-thought-out project proposal that:

- Addresses a clear need related to ARPA's eligible spending categories
- Takes advantage of opportunities for collaboration
- Has a detailed evaluation process
- Is accessible and inclusive for Knox County residents.

The application deadline for the Round 1 funding cycle is May 16, 2022. Applications will be reviewed by Knox County ARPA Advisory Task Force and recommended for funding to the Knox County Board. Final decisions rest with the Knox County Board.

Application Submission Instructions

- 1. Fill out the following application by completing all required fields. Incomplete applications will not be considered. If an application is incomplete, it will be returned to the applicant and may be resubmitted for future consideration if funding is still available.
- 2. Email completed applications and all supporting documents, with the subject line "ARPA Application Entity Name", to ARPAapplications@knoxcountyil.gov (Example: ARPA Application At Your Door Food Delivery) ALL APPLICATIONS MUST BE SUBMITTED ELECTRONICALLY BY 4 p.m. ON MAY 16.
- 3. During the review process, the Task Force may request additional documentation or other information concerning the proposal or the entity submitting the application.

IMPORTANT NOTICE:

All recipients of Recovery Funds are required to comply with federal Uniform Guidance. This includes, but is not limited to:

- keep records for five (5) years after funds have been expended;
- comply with all Civil Rights Compliance requirements
- ensure that any procurement using Recovery Funds, or payments under procurement contracts are consistent with procurement standards; all procurement transitions shall follow full and open competition and use documented procedures to avoid conflicts of interest
- recipients that spend more than \$750,000 are subject to the Single Audit Act.

Awardees will be required to attest to their agreement to all these conditions.
