Sheriff Harlan delivered the Proclamation and Chair Hawkinson led the Members in the pledge of allegiance to the flag. In lieu of a formal invocation, Chair Hawkinson asked that a moment of silence be observed.

Chair Hawkinson asked for additions to the agenda. There were no additions. Chair Hawkinson announced that there would be a three-minute closed session for Personnel before adjourning.

Chair Hawkinson asked for public comment. There was no public comment.

Motion was made by Member Friedrich and seconded by Member Weiss to approve the Payment Application 1 for Phase 2 of the Performance Contract with MSI. Chair Hawkinson said this is about the \$1,349,485.20. He said that he sent the legal explanation from the State's Attorney at 1:56pm on the 26th to the G-drive. He asked if everyone was able to read the correspondence, understand it, and if anyone had questions. He said that an emergency is not bid out so that is when we can get an itemized bill. For Phase 1 & 2 it was bid out. He said how it was explained to him that since it was bid out we have to pay what the bid was for. If the bid would have been for \$10,000 and the work was completed by the general contractor. If the contractor spent \$50,000 they still only get \$10,000.

Member Cohen said so regardless of what the break down is, since it was bid we have to pay what the bid is.

Chair Hawkinson said yes.

Member Davidson said that on last Wednesday you said that you had asked for a material list that you did not have yet.

Chair Hawkinson said that he misspoke and that he did not have the bid information in front of him. He said that there was an emergency 3 or 4 weeks ago and the itemization was for that week.

Member Davidson said so you misspoke. I just wanted to make sure that was heard.

Member Boone said that she also misspoke when I said abstain last week. Now I know I can change that. Roll call vote is recorded as follows: Ayes—Bacon, Hawkinson, Sandoval, Weiss, Kramer, Friedrich, Olinger and Boone—(8). Noes—Nache, Davidson, Pugh, Thierry, and Cohen----(5). Motion carried.

Motion was made by Member Friedrich and seconded by Member Thierry for the Board to go into Closed Session at 6:12 p.m. for Personnel.
