Office hours are Mon. - Fri., 8:30 a.m. - 4:30 p.m. Complete form, present acceptable identification (and any necessary documentation), and make payment in form of cash, check-payable to "Knox County Clerk", credit or debit.
BY MAIL 	Complete form, make copy of acceptable identification (and any necessary documentation), and make payment in form of MONEY ORDER payable to "Knox County Clerk". Send to Office of the Knox County Clerk, 200 S. Cherry St., Galesburg, IL 61401.
ONLINE 	Visit www.knoxclerk.org . Make payment through Illinois E-Pay using credit card (Visa, MasterCard, Discover) and email vitalrecords@knoxcountyil.gov or fax acceptable identification (and any necessary documentation) to 309/345-3801.
