- Submit a copy of your identification (see below for acceptable forms of identification).
- Include your payment (see below for acceptable forms of payment).

BY MAIL	Complete form, make copy of acceptable identification (and any necessary documentation), and make payment in form of MONEY ORDER payable to "Knox County Clerk". Send to Office of the Knox County Clerk, 200 S. Cherry St., Galesburg, IL 61401.
